

APPOINTMENT OF 1 x SPECIAL PROSECUTOR ON CONTRACT BASIS

1. Headquarter Anti Narcotics Force Rawalpindi requires the services of energetic and hardworking Advocates for contesting ANF cases in Special Court (CNS), Anti Smuggling Court, High Court and Apex Court on contract basis.
2. The Advocates fulfilling following criteria can apply:-
 - a. The candidates shall be persons who are citizen of Pakistan.
 - b. The candidates shall be practicing as an advocate of High Court with experience in legal matters preferably dealing with drug cases / Assets Cases.
 - c. The candidates shall neither have been guilty of misconduct during the professional career nor convicted of any offence of moral turpitude nor dismissed from Government Service nor declared as insolvent.
 - d. The candidates after selection may be appointed anywhere in Pakistan.
 - e. The candidates having Supreme Court experience will be given preference.
3. Attractive retainership fee will be offered, which is mutually negotiable.
4. The Special Prosecutor shall conduct proceedings under the control of Narcotics Substances Act, 1997 (XXV of 1997), Prevention of Smuggling Act, 1977 and Anti Money Laundering Act, 2010 in narcotics cases / assets cases on behalf of Headquarter Anti Narcotics Force Rawalpindi before Special Court (CNS), Anti Smuggling Court, High Court and Apex Courts and shall not appear in any narcotics case / assets case in defence of an accused.
5. Interviews will be held at Headquarter Anti Narcotics Force Wavell Lines, Opposite Old Benazir Bhutto International Airport, Chaklala, Rawalpindi. No TA/ DA will be admissible.
6. The selection will be made purely on merit.
7. Incomplete applications will not be entertained.
