Objective

To maximize effectiveness of Anti Narcotics Policy of the Government of Pakistan through coordinated implementation of the Counter Narcotics Enforcement Strategy, with a view to making Pakistan a drug free state.

Scope

The Task Force members will meet on quarterly basis to assess the performance of all Law Enforcement Agencies, coordinate efforts and resources, with a view to implementing the strategy. All members nominated by the heads of relevant agencies/departments as focal persons shall attend the meetings and present reports of their performance.

The performance of each department will be compiled and a report will be sent to the respective head of the department on regular basis.

Presentation will be made before the National Narcotics Interdiction Committee in the Narcotics Control Division based on the progress of the Inter Agency Task Force (IATF).

Secretariat

The secretariat of the task force will be located in the ANF HQ Rawalpindi. Director Enforcement, HQ ANF Rawalpindi will be in incharge of the Secretariat under the overall control of DG ANF. He will coordinate all operations, reports and returns, analyze the performance of the LEAs and advise the DG ANF accordingly to bring improvements.
