MAJOR SEIZURES

2005 Kg Hashish Seized at Qilla Abdullah

On 1 July 2013, ANF Balochistan recovered **2005 Kg Hashish** from a dry seasonal Nullah at Qilla Abdullah.

1943 Kg Opium Seized at Pishin

On 17 July 2013, ANF Balochistan recovered **1943 Kg Opium** seized at deserted hut in general area at Pishin.

1545 Kg Opium Seized at Qilla Abdullah

On 28 July 2013, ANF Balochistan recovered **1545 Kg Opium** seized at deserted hut foothills from mountain area at Qilla Abdullah.

490 Kg Opium and 51 Kg Heroin Seized at Panjgur

On 13 July 2013, ANF Balochistan recovered **490 Kg Opium** and **51 Kg Heroin** from a Toyota Single Cabin at Panjgur after exchange of heavy fire.



202 Kg Heroin seized at KICT, Sea Port

On 30 July 2013, ANF Karachi recovered **202 Kg Heroin** seized at Karachi International Container Terminal (KICT), Sea Port Karachi from a container destined to Colombo (Sri Lanka).

139 Kg Hashish and 3.30 Kg Heroin Seized at Khanawal

On 12 July 2013, ANF Punjab recovered 139 Kg Hashish and **3.30 kg Heroin** from a Honda Civic car at Khanawal.

110 Kg Heroin seized at Kuala Lumpur, Malaysia

On 22 July 2013, on the information of Special Investigation Cell Islamabad by Royal Malaysian Police recovered **110 Kg Heroin** at Kuala Lumpur, Malaysia.

13 Kg Heroin Seized at Islamabad

On 7 July 2013, ANF Rawalpindi recovered **13 Kg Heroin** from personal possession of a passenger at BBIAP Islamabad.



10 Kg Heroin Seized at Peshawar
