ANF SEIZED 3302.47 KGS DRUGS VALUING US\$ 1.051 BILLION IN 27 OPERATIONS ARRESTED 21 PERSONS INVOLVED IN DRUG TRAFFICKING & ALSO IMPOUNDED 9 VEHICLES INCLUDING ONE BOAT

Proving its commitment to eradicate drugs from our homeland, Anti Narcotics Force Pakistan seized **3302.47 Kgs** narcotics valuing US\$ **1.051** Billion internationally, arrested **21** culprits and impounded **9** vehicles including one boat in conducting **27** counter-narcotics strikes throughout the country. The seized drugs comprised of **2189.5** Kg Hashish, **92.317** Kg Heroin, **52.400** Kg Opium, **0.250** Kg Methamphetamine, **961** Kg Morphine, **0.247** Kg Diazepam Tab, **0.400** Kg Ecstasy Tab, **2.500** Kg Hashish Oil & **3.856** Kg Suspected Chemical.

ANF Balochistan, the staff of Police Station Nokundi, Balochistan recovered **50 Kg Opium** from Killi Hassanabad at Tehsil Nokundi & District Chaghi, Balochistan. In another operation, the staff of Police Station Turbat recovered **50 Kg Heroin** from **Corolla X-Car** at Mirani Dam road near D Baloch Kech Core Tehsil Turbat District Kach. In third operation, Police Station Turbat recovered **500 Kgs Hashish** from dry rainy nullah situated near M-8 Turbat Gwadar road District Kech. In fourth operation, the staff of Police Station Regional Directorate Balochistan recovered **961 Kgs Morphine** from Qilla Koulak Tehsil Gulistan & District Qilla Abdullah.

ANF Rawalpindi, the staff of Police Station ICT Islamabad during routine checking at International Mail Office, Chaklala Garrison, Rawalpindi recovered **0.086 Kg Diazepam Tabs (Qty 457)** from suspected parcel. The parcel was being sent to Australia. Sender name of suspect parcel Mujahid Abbas resident of Multan & Recipient Ms Jade Baird FAO Neil Isles 3/41, Paringa road Muarrie QLD 4172, Australia. In another operation, Police Station ICT, Islamabad during routine checking of International Mail Office Chaklala Garission, Rawalpindi intercepted a parcel being sent to UK and recovered **0.086 Kg Diazepam Tab (Qty 457)** from the said parcel. Sender name of the said parcel S Dilshad resident of Lahore and recipient name Mark Dewar 8, Sydney Street, Craigs Hill, Livingston EH54 5HH UK. In third operation, the staff of Police Station ICT, Islamabad during routine checking of International Mail office Chaklala Garrison, Rawalpindi intercepted a parcel being sent to UK and recovered **0.075 Kg Diazepam Tab (Qty 400)** from the said parcel. Sender name of said parcel S Dilshad resident of Lahore and recipient name Sonia Mr Daren Gordon 5 Hammond Court, Watermill Lane, London NI18 1FA UK. In fourth operation, the staff of Police Station Regional Directorate intercepted a suspected consignment from IDHS Courier & Cargo service office, Al-Bilal Plaza, Chandni Chowk, Rawalpindi and recovered **2.740 Kg Heroin (Brown)** wrapped in 2 x hoods from said parcel of one card board box containing 15 x Gents Hoods & 10 x Pants. The Parcel was booked by Muhammad Wajid resident of Islamabad with CNIC copy in the name of Zafar Ullah Khan resident of Karachi East and was being sent to Maria Kristalova resident of Brad Ford, UK. In fifth operation, the staff of Police Station Gilgit conducted an operation at Ehsan Ali link road, Kashrote, District Gilgit and recovered **1.400 Kg Hashish** from his personal possession of arrested accused **Latif Anwar** resident of District Gilgit. In sixth operation, the staff of Police Station Islamabad intercepted Honda **Motorcycle** near G-13, Markaz, Islamabad and recovered **2.330 Kg Hashish oil** from personal possession of arrested accused namely **Kashif Marwat and Sohail Anjum Qureshi** residents of Islamabad. On Pointation of arrested accused, the staff of Police Station conducted further raid on a narcotics manufacturing laboratory covert from the House situated in Islamabad and seized **0.170 Itrs Hashish Oil** and **3.856 Kg Suspected Chemical** and other drugs manufacturing equipment from the house. In Seventh operation, Police Station Regional Directorate intercepted a Pakistani

national accused **Fayaz** resident of Swabi at Islamabad Airport who was travelling to Madina (KSA) through flight No.PK-9713 and recovered **3.627 Kg Heroin** from his trolley bag plastic hard sheets.

ANF Punjab, the staff of Police Station Faisalabad raided near Sannat Singh Railway Crossing Jhumra road, Faisalabad and recovered **1.500 Kg Hashish & 0.250 Kg Methamphetamine** from **Suzuki Mehran Car. Muhammad Nadeem** resident of Sargodha was arrested on the spot. In another operation, the staff of Police Station Mianwali raided near Chowk Azam, Sofia Hotel & Restaurant MM road District Layyah and recovered **3.500 Kg Hashish** from the arrested accused namely **Saeed Abbas** resident of Layyah. In third operation, the staff of PS Faisalabad intercepted a **Motorcycle** near Marzipura -Chowk Ameenpur road Faisalabad and recovered **4.800 Kg Hashish** from personal possession of the arrested accused namely **Muhammad Akram and Amir Shahazad** residents of Faisalabad. In fourth operation, Police Station Faisalabad intercepted a Pakistani national accused namely **Mazhar Saleem** resident of Azad Jammu & Kashmir at International Airport Faisalabad who was travelling to Dubai through flight No.FZ-344 and recovered **1.218 Kg Heroin** which was tactfully concealed in the bottom of his bag. In fifth operation, ANF Lahore intercepted a suspected parcel at TCS Office Cargo Complex Allama Iqbal International Airport, Lahore which was booked for UK. After thoroughly checking of parcel which was consisted of four Trays, six Glasses, Sixteen Cups and one Pot and recovered **1.182 Kg Heroin** which was tactfully concealed in one pot. Sender of the parcel name Muhammad Ismail resident of Peshawar and recipient name Raja Adil Mana resident of UK. In sixth operation, the staff of Police Station Multan intercepted two vehicles near Toll Plaza Tounsa Sharif Indus Highway Tehsil Tounsa Sharif District DG Khan and recovered **238.800 Kg Hashish** from secret cavities made in two seized vehicles/cars. Four accused namely **Muhammad Shafi, Rooh Ullah, Najeeb Ullah and Wazir Muhammad** residents of Qilla Abdullah, Quetta were arrested on the spot. In Seventh operation, ANF Lahore intercepted a suspected parcel at DHL Office Cargo Complex Allama Iqbal International Airport, Lahore who was booked for UK. After checking of said consignment/parcel which was consisted of 28 x Ladies Suits (Farak) and recovered **1.750 Kg Heroin** which was tactfully concealed in one lady suit (Farak). The sender name of the consignment / parcel Muhammad Ayaz resident of Lahore and recipient name Aniz Ahmad resident of UK.

ANF Sindh, the staff of Police Station Regional Directorate conducted a raid at Gezri Pull Clifton Karachi and recovered **7.200 Kg Hashish** from personal possession of the arrested accused namely **Barat Khan** resident of Qilla Abdullah, Balochistan. In another operation, the staff of Police Station Regional Directorate in collaboration with Pakistan Maritime Security Agency (PMSA) Karachi, intercepted 1 x Stateless Boat namely Al-Bilal at Open Sea Opposite Howkesbay, Karachi and recovered **1372 Kg Hashish** which was destined to South Africa. Three accused namely **Nadir, Hammal** residents of Lasbela Balochistan & **Adnan** resident of Karachi were arrested on the spot. In third operation, Police Station ANF Sindh Gulshan-e-Iqbal, Karachi intercepted a **Hino Truck** near Total Petrol Pump Al Asif Square Super Highway, Karachi and recovered **25 Kg Heroin** from seized Truck. Accused **Jasif** resident of Balochistan was arrested on the spot. In fourth operation, the staff of Police Station Gulshan-e-Iqbal Karachi intercepted a **Toyota Filder Car** near Bus Terminal Hasool Petrol Pump, Sohrab Goth, Karachi and recovered **5.400 Kg Heroin** from seized vehicle. Two accused namely **Muhammad Khan and Ghulam Hussain** resident of Balochistan were arrested on the spot. In fifth operation, the staff of Police Station Korangi, Karachi intercepted a parcel at M&P Courier Company Karachi booked from

M&P Office Batkhela, KPK by Khial Muhammad resident of Malakand KPK being sent to Sohail resident of UK and recovered **1.400 Kg Heroin** concealed in Wooden Box.

ANF KP, on tip off Police Station Kohat in collaboration with Kurram Militia FC (S) intercepted a **vehicle** at Balish Khel Tehsil & District Khurram and recovered **18 Kg Hashish**, which was concealed in seized vehicle. Accused namely **Mehboob Ali** resident of Upper Khurram was arrested on the spot. In another operation, the staff of Police Station Peshawar Torkham Det in collaboration with NLC at Torkham Border Trade recovered **400 grams Ecstasy Tabs (Qty 800)**, which was tactfully concealed in wireless audio speakers. In third operation, On tip off Police Station Peshawar in collaboration with FC (North) recovered **2.400 Kg Opium & 9.300 Kg Hashish** from a dried nullah near Takhta Bagh CP District Khyber. The drugs were hidden for onwards smuggling to Peshawar. In fourth operation, Police Station Kohat in collaboration with FC (South) recovered **33 Kg Hashish** near Manojaba District Khurram.

All cases have been registered at respective ANF Police Stations under CNS Act 1997 and further investigations are underway.
