- Bids may be submitted on the address in a SEALED CONFIDENTIAL COVER for each category latest by **16 Jan 2018 before 1100 hours**. No tender will be accepted after cut down date and time. The bids will be opened on the same date at **1130 hours** in the presence of desirous bidders or their representatives.
- All the proposals and prices shall remain valid **upto 30 June 2018** for the financial year 2017/2018 from the closing date of the submission of the proposal/tender.
- All currency in the proposal shall be quoted in Pakistan Rupees (PKR).
- The bidder is hereby informed that the Government shall deduct tax at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- The quoted price should include all the Government taxes.
- Bidder should clearly indicate the duration of delivery of equipment after the award of contract.
- Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.
- The successful bidder will have to supply the items as per our demand, failing which, order will be cancelled and earnest money will be forfeited in favour of HQ Anti Narcotics Force.
- HQ Anti Narcotics Force, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
- A bid bond, in the shape of a Bank Draft/Pay Order in the name of HQ Anti Narcotics Force, Rawalpindi amounting to Rs. 50,000/-(Rupees Fifty Thousand Only) for each category (refundable) should be submitted along with tender as security deposit

- Bidders are bound to provide samples of all items except toners/cartridge
- Documents required for the Pre-Qualification of the contractors/firm are as under:-
 - ✓ Registration certificate of FBR for GST & NTN.
 - ✓ Detail of previous five years work (experience details)
 - ✓ Certificate on stamp paper that the firm/contractor has not been blacklisted and there is no case of litigation against contractor/firm.
 - ✓ Distribution cert from distributor of dog feeds
 - ✓ If distribution cert is not held then provide a stamp paper, with clear mentioning that items including in list must be provided for whole year, In case of failure in provision of dogs feed my firm/company is liable to be black listed.
