This organization requires sealed tenders from interested /capable General Sales Tax (GST) holder firms/ organizations/ venders for purchase and installation of Solar Energy System at Headquarters Anti Narcotics Force Rawalpindi. 2. **Terms & Conditions**

- a. Bids may be submitted on the address in a SEALED CONFIDENTIAL COVER for each category latest by **20 Nov 2017 (Monday) before 1200 hours**. No tender will be accepted after cut down date and time. The bids will be opened on the same date at **1400 hours**.
- b. A bid bond, in the shape of a Bank Draft / Pay Order in the name of Headquarters Anti Narcotics Force, Rawalpindi amounting to Rs 2.5% (refundable) of total cost should be submitted along with tender as security deposit.
- c. All the proposals and prices shall remain valid **upto 30 Jun 2018**.
- d. All currency in the proposal shall be quoted in Pakistan Rupees (PKR).
- e. The bidder is hereby informed that the Government shall deduct taxes at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- f. Bidder should clearly indicate the duration of delivery of equipment and installation after the award of contract.
- g. Bidders will be required to arrange a pre order demonstration of equipment before final delivery and installation at HQ ANF Rawalpindi.

- h. Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.
- i. The successful bidder will have to deliver the equipment and install as per our demand, failing which, order will be cancelled and earnest money will be forfeited in favour of HQ Anti Narcotics Force.
- j. HQ Anti Narcotics Force, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
- k. HQ Anti Narcotics Force, Rawalpindi will announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract.
- l. The bidder should submit his Technical and Financial bid separately in two envelopes. Technical bid should contain the technical expertise held with the firm, their past experience and any projects related to the tender under taken. Financial proposal should contain the rates (including all taxes) of the work to be undertaken.
- m. All bidders offering the product should be authorized dealer/ vendor of the Original Equipment Manufacturer (OEM).
- n. All bidders participating in the tender should be registered with FBR and must be included in active tax payer list maintained by FBR. Also produce following documents alongwith technical bid:-
 - (1) PEC Registration.
 - (2) Affidavit of Black List.
 - (3) Past Experience Cert.
 - (4) Bank Statement last six months.
