**PRE-QUALIFICATION OF AUTOMOBILE WORKSHOP/ FIRMS/ COMPANIES**

1. Government of Pakistan, Ministry of Narcotics Control, Anti Narcotics Force Headquarters Rawalpindi, a Premier Drug Law Enforcement Agency of Pakistan intends to Pre-qualify, Automobile Workshops/ Firms/ Companies for **Repair/ maintenance, Denting & Painting, Air Conditioning Work, Provision of Spares Parts, Tyres, Tubes & Batteries of Vehicles (LTV & HTV) and Repairing/ Maintenance of Motorcycles** for the financial year **2021-2022**. The well reputed Automobile Workshops/ Firms/ Companies having experience in the field of Automobile registered with FBR for NTN & GST are invited for participation.
2. Pre-qualification documents, which are containing detailed terms and conditions, procedure for submission of applications evaluation criteria, performance guarantee etc can be obtained from Headquarter Anti Narcotics Force, Wavel Lines Chaklala, Opposite Noor Khan Air Base (Old Benazir Bhutto International Air Port), Rawalpindi from **1000 to 1400 hrs**.
3. Documents required for Pre-qualification of Automobile Workshops / firms/ Companies are as under:-
  - a. Approved certificate of Government department.
  - b. Registered with FBR (valid GST & income tax registration certificate)
  - c. Certificate of sound financial position of contractors.
  - d. Previous five years work experience details.
  - e. Detail of equipment, machinery, & labour held.
  - f. Certificate on stamp paper that the Automobile Workshop/ firm/ Companies has not been blacklisted ever.
  - g. Certificate of good reputation from Departments working with.
  - h. Certificate that there is no case/ litigation against Automobile Workshop/ firm/ Companies. If found any stage the Automobile Workshop/ firm/ Companies will be black listed.
  - i. Bank guarantee of the Automobile Workshop/ firm/ Companies.
  - j. The tender opening committee has reserved the rights for acceptance/ rejection of all/ any tender, any time prior to acceptance of proposal, due to some valid reason and non fulfilment of pre-qualification tender requirements mentioned in para 3 a to i.
4. The proposals, prepared in accordance with the instructions in the pre-qualification documents, must reach by **1130 hrs** on or before **20 May 2021**. **Applications received after 1130 hrs on 20 May 2021 will not be accepted**. Proposals will be opened in presence of owner/ rep from Automobile Workshop/ firm/ Company on **20 May 2021 at 1130 hrs**.
