- All the proposals and prices shall remain valid **upto 30 June 2019** for the financial year 2018/2019 from the closing date of the submission of the proposal/tender.
- All currency in the proposal shall be quoted in Pakistan Rupees (PKR).
- The bidder is hereby informed that the Government shall deduct tax at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
- The quoted price should include all the Government taxes.
- Bidder should clearly indicate the duration of delivery of equipment after the award of contract.

- Proposals shall be delivered by hand or courier so as to reach the address given below before closing date and time. PROPOSAL RECEIVED BY FAX OR EMAIL SHALL NOT BE ACCEPTED.
- The successful bidder will have to supply the items as per our demand, failing which, order will be cancelled and earnest money will be forfeited in favour of HQ Anti Narcotics Force.
- Anti Narcotics Force HQ, Rawalpindi reserves the right to reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
- A bid bond, in the shape of a Bank Draft/Pay Order in the name of Anti Narcotics Force HQ, Rawalpindi amounting to Rs. 50,000/- (Rupees Fifty Thousand Only) for each category (refundable) should be submitted alongwith tender as security deposit
- Bidders are bound to provide samples of all items except toners/cartridge
