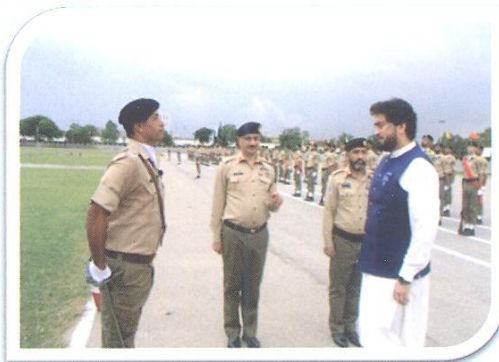
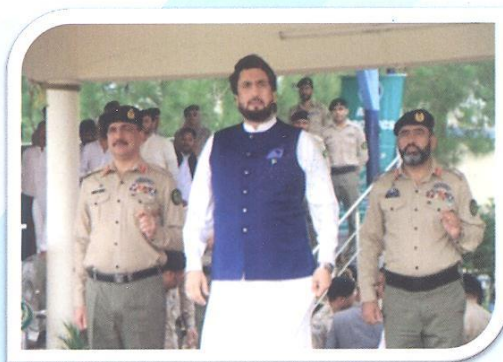
5. ANTI NARCOTICS FORCE ACADEMY (ANFA)
