MAJOR SEIZURES

3 Kg Heroin Seized at Peshawar

On 1 August 2013, ANF Khyber Pakhtunkhwa recovered **3 Kg Heroin** from Wash Room of Peshawar Airport.

855 Kg Opium and 100 Kg Morphine Seized at Mastung

On 3 August 2013, ANF Balochistan recovered **855 Kg Opium** and **100 Kg Morphine** from a deserted hut in mountainous area of Mastung.

1.06 Kg Methamphetamine(Ice) Seized at Islamabad

On 6 August 2013, ANF Rawalpindi recovered **1.06 Kg Methamphetamine (Ice)** from personal possession of a passenger at BBIA Islamabad.

15000 Liters of Acetic Anhydride Seized at Rawalpindi

On 15 August 2013, ANF Rawalpindi recovered **15000 Liters of Acetic Anhydride** from a container at Rawalpindi.

4.71 Kg Heroin Seized at Islamabad

On 19 August 2013, ANF Rawalpindi recovered **4.71 Kg Heroin** from personal possession of a passenger at BBIA Islamabad.

86.40 Kg Hashish, 20.40 Kg Opium and 1 Kg Heroin Seized at Peshawar

20 August 2013, ANF Khyber Pakhtunkhwa intercepted a Suzuki (Every) near Motorway Toll Plaza Peshawar and recovered **86.40 Kg Hashish, 20.40 Kg Opium** and **1 Kg Heroin**.

96 Kg Hashish Seized at Sargodha

20 August 2013, ANF Punjab intercepted a Honda Saloon car at Salam Interchange Motorway Sargodha and recovered **96 Kg Hashish**.

7 Kg Heroin Seized at Islamabad

On 23 August 2013, ANF Rawalpindi intercepted 2 x cars at BBIA Islamabad and recovered **7 Kg Heroin**.

113 Kg Hashish Seized at Karachi

26 August 2013, ANF Sindh intercepted a Hino truck near Raees Goth Hub River Road Karachi and recovered **113 Kg Hashish**.

562 Kg Hashish and 2 Kg Heroin Seized at Karachi

29 August 2013, ANF Sindh intercepted a Suzuki Mehran car near Tool Plaza Super Highway Karachi and recovered **562 Kg Hashish** and **2 Kg Heroin**.

40 Kg Heroin Seized at Mianwali
