MAJOR SEIZURES

375 Kg Heroin Seized at Karachi

On 3 December 2013, ANF Sindh intercepted a container destined to Kampala (Uganda) at Qasim International Container Terminal (QICT) Karachi and recovered **375 Kg Heroin**.

153 Kg Heroin Seized at Peshawar

On 3 December 2013, ANF Khyber Pakhtunkhwa intercepted a Bedford truck near Fatih Gul Khan Workshop Ring Road Peshawar and recovered **153 Kg Heroin**.

60 Kg Hashish Seized at Quetta

On 3 December 2013, ANF Balochistan recovered **60 Kg Hashish** from a room of Musafir Khana, Umar Plaza Hazar Ganji District Quetta.

6 Kg Herion Seized at Rawalpindi

On 4 December 2013, ANF Rawalpindi intercepted a consignment being sent to UK through International Courier and Cargo Services Rawalpindi and recovered **6 Kg Heroin**.

660 Kg Hashish Seized at Sukkur

On 6 December 2013, ANF Sindh intercepted a Hino Mini Truck near Toll Plaza Rohri, Sukkur and recovered **660 Kg Hashish**.

116 Kg Hashish Seized at Sukkur

On 6 December 2013, ANF Sindh intercepted a Toyota Corolla car near Toll Plaza Rohri, Sukkur and recovered **116 Kg Hashish**.

201 Kg Hashish Seized at Peshawar

On 7 December 2013, ANF Khyber Pakhtunkhwa recovered **201 Kg Hashish** dumped in bushes near Masjid Hazrat Yousaf, Ring Road Peshawar.

7.70 Kg Herion Seized at BBIA Islamabad

On 14 December 2013, ANF Rawalpindi intercepted/ arrested 1x Pakistani at Benazir Bhutto International Airport (BBIA) Islamabad, travelling to Italy via Abu Dhabi and recovered **7.70 Kg Heroin** from his personal possession

1.50 Kg Cocaine Seized at Karachi

On 14 December 2013, ANF Karachi intercepted/ arrested 1x Filipino woman at Jinnah International Airport (JIAP) Karachi, arrived from Peru via Dubai and recovered **1.50 Kg Cocaine** from her personal possession. .

90 Kg Hashish & 30 Kg Opium Seized at Attock

On 19 December 2013, ANF Rawalpindi intercepted a truck at Grand Trunk Road near Burhan Interchange Motorway Attock and recovered **90 Kg Hashish** and **30 Kg Opium**.

2 Kg Cocaine Seized at BBIA Islamabad

On 21 December 2013, ANF Rawalpindi intercepted/ arrested 1x Filipino women at Benazir Bhutto International Airport (BBIA) Islamabad, arrived from Dubai and recovered **2 Kg Cocaine** from her personal possession.

162 Kg Hashish Seized at Khanewal

On 24 December 2013, ANF Punjab intercepted a Toyota Premio car near Usman Petroleum Khanewal-Bahawalpur Road Tehsil Jahanian District Khanewal and recovered **162 Kg Hashish**.

300 Kg Hashish Seized at Peshawar

On 25 December 2013, ANF Khyber Pakhtunkhwa recovered **300 Kg Hashish** from an unattended Suzuki Pick-up parked near under construction plaza, Bara Road Peshawar.
