MAJOR SEIZURES

3725 Kgs Hashish seized at Qillah Abdullah

On 1 January 2014, ANF Balochistan recovered **3725.00 Kgs Hashish** from a Dry Seasonal Nullah in general area Killi Sehgi Tehsil Gulistan Distt Qillah Abdullah

235 Kgs Hashish seized at Turbat

On 2 January 2014, ANF Balochistan recovered **235.00 Kgs Hashish** from a mountains area near Pasni Road Distt Turbat

3082 Kgs Hashish seized at Qillah Abdullah

On 10 January 2014, ANF Balochistan recovered **3082.00 Kgs Hashish** from a deserted hut in general area Killi Shedizai Tehsil Gulistan Distt Qillah Abdullah

68.10 Kgs Heroin seized at Karachi

On 11 January 2014, ANF Sindh intercepted a container, destined to Malaysia at QICT, Seaport Karachi and recovered **68.10 Kgs Heroin**

1.20 Kgs Cocaine seized at Rawalpindi

On 12 January 2014, ANF Rawalpindi intercepted 1x Filipino woman arrested at BBIA Islamabad, arrived from Dubai by flight EK-614 and recovered **1.20 Kgs Cocaine** from her personal possession

9.50 Kgs Heroin, 1 Kg Hashish, 1 Kg Opium seized at Mianwali

On 23 January 2014, ANF Punjab intercepted an Axio car at Rakhi Morr Talagang Road Distt Mianwali and recovered **9.50 Kgs Heroin, 1.00 Kg Hashish and 1.00 Kg Opium**
