- e. Fixed Bid Security shall be submitted originally (in form of hard copy) in the light of PPRA rules in an envelope clearly marked with the tender No. & Title before the e-bid submission deadline in the office of Major Atta Hussain, Deputy Director (Admin), HQ Anti-Narcotics Force Wavel Lines, Opposite Nur Khan Air Base Chaklala, Rawalpindi.
- f. Vender must quote 100% of each lot. The bid having partially quoted quantities less than 100% of each lot quantity may lead to bid rejection.
- g. Cumulative price of entire lot will be considered.
- h. Pay Order (CDR) in favour of HQ Anti-Narcotics Force Rawalpindi.
- i. The bid will be considered as "non-responsive" if the bid security is less than the above fixed amount.
- j. Tender with any condition will be considered "non-responsive".

- k. Unit price should be in PKR including all applicable taxes.
- l. Period of delivery within 7 days after issuance of purchase order on demand basis for FY 2026-27.
- m. Documents required from contractors/ firms are as under:-
